It is now possible to end self-isolation after 5 full days if you have 2 negative LFD tests taken on consecutive days. The first test should not be taken before the fifth day after your symptoms started (or test day). The self-isolation period remains 10 full days for those without negative results from 2 LFD tests taken a day apart.</li> <li>• From 27 January face coverings will no longer be advised for staff and pupils in communal areas of primary schools.</li> </ul>

The government suggests that you continue to wear a face covering in crowded and enclosed spaces where you may come into contact with other people you do not normally meet.</li> </ul>

A member of the School Office team will be responsible for their safety and collection. When collected, the member of the School Office team will wipe down all surfaces in the foyer as well as following good personal hygiene procedures.</li> <li>• If the staff member or pupil's PCR test result return is negative, they will be permitted to attend school so long as they are well enough to do so.</li> </ul>

The staff member or pupil can return to school on the 11<sup>th</sup> day, if they are well enough to do so.</li> <li>• Staff member or parent of pupil will be asked to inform NHS Test and Trace to help identify potential close contacts.</li> <li>• <b>On Day 5 and Day 6, the pupil or staff member can take a LFD Test. If both tests are taken 24 hours apart and both have negative results, the self-isolation can end immediately after the second negative LFD Test result.</b></li> <li>• Close contact individuals are not required to self-isolate if they are fully vaccinated, below the age of 18 years and 6 months, have taken part in an approved COVID19 vaccine trail or are unable to get</li> </ul>

				<p>vaccinated for medical reasons. Close contacts are strongly advised to take a daily LFD Test for 7 days.</p> <ul style="list-style-type: none"> <li>• If a member of a pupil's household tests positive, parents will be advised that all other members of the household should take daily LFD Tests for 7 days. In such circumstances, children are permitted to attend school if they have negative LFD Test results, are well and show no symptoms.</li> <li>• The school will inform parents of pupils in the class with a confirmed positive case.</li> <li>• For pupils who are instructed to self-isolate because they display COVID19 symptoms and/or have tested positive for COVID19 through a PCR test, remote learning opportunities will be put in place if they are well enough to access them.</li> </ul>

				<p>Therefore, an initial response will include the SLT checking ventilation measures, cleaning regime, LFT testing and hand hygiene measures and introducing restrictions on mixing across phases and adapting school routines. If cases continue to rise, a second wave of measures, including cancelling events, clubs etc. will be introduced.</p> <ul style="list-style-type: none"> <li>• The SLT will consult with Lancashire COVID response team to confirm that appropriate measures are put in place that help to reduce the risk of transmission without impacting negatively on pupils' education.</li> <li>• The measures will be reviewed daily, with a final review at the end of a 10 school day period. If it is deemed that the measures have been successful, the restrictions will be lifted to the 'limited restrictions' level, including ventilation, hand hygiene, cleaning regime etc.</li> </ul>
1.6	An outbreak of COVID19 within school: COVID cases continue to rise rapidly within a 10 day period despite additional measures. 1.7	An outbreak of COVID19 results in a high number of staff members testing positive and being required to self-isolate or dependents testing positive and them being required to support childcare arrangements. A timetable will be agreed and monitored. The school adviser and Chair of Governors will be consulted if the situation arises that classes cannot be adequately and safely covered.</li> <li>• Supply staff will be employed where possible to cover teacher absence.</li> </ul>



				<ul style="list-style-type: none"> <li>• Teachers with less teaching time will be utilised as appropriate to cover teacher absence.</li> <li>• Teaching Assistants will be utilised to cover for shorter periods of time if necessary. In such cases, the school will aim to double up Teaching Assistants so that two members of non-teaching staff are covering a class.</li> <li>• Lunch time duty will be reviewed to ensure that an adequate number of staff are available to cover supervision during the lunchtime break. The school will strive to meet 1:30 adult to child ratio. In cases of limited lunch time staff, class teachers will be asked to cover on a rota basis for short periods of the lunch break.</li> <li>• In the event that a class cannot be adequately covered and the SLT deem that it would be unsafe (for example, no qualified teacher to lead a specific class with high needs or no paediatric first aid trained member of staff on site); parents will be notified of an unavoidable school closure for a specific class. The number of days of closure will be kept to an absolute minimum and parents will be informed with as much notice as possible.</li> </ul>

				<ul style="list-style-type: none"> <li>○ Regular hand washing encouraged with sanitiser and hand soap available at all times.</li> <li>○ Catch it, bin it, kill it procedure in place.</li> <li>○ ICS (cleaning company) instructed to ensure that all common touch points are cleaned daily.</li> <li>○ Additional midday clean of all toilet areas.</li> <li>○ Class teachers to wipe down table tops and other key touch point areas with sanitising spray at lunchtime.</li> <li>○ Face coverings are optional in communal areas.</li> <li>○ Good ventilation will be in place with class teachers ensuring that classrooms are adequately ventilated whilst still allowing for the maintenance of a comfortable working environment.</li> <li>○ CO2 monitors are used in classrooms to monitor the air quality. These should be regularly charged and referred to by class teachers.</li> <li>○ Anyone showing COVID19 symptoms will be sent home and instructed to book a PCR test and self-isolate until the test results are returned (see sections 1.4/1.5)</li> <li>○ Twice weekly Lateral Flow testing in place with all staff and regular visitors encouraged to undertake.</li> </ul>
2.1	Transmission of COVID19 during travel to and from school on dedicated transport, including trips/swimming.	Staff, pupils	Potential spread of infectious disease	<ul style="list-style-type: none"> <li>● The school expects, and requests a copy of, the travel company's risk assessment in relation to transporting children safely under COVID19 and being COVID secure. The school should have this available to anyone at request.</li> <li>● Assurances have been given by transport providers that transport is cleaned regularly and that high touch points are sanitised prior to a school pick up/drop off.</li> <li>● Hand sanitiser is used upon boarding and/or disembarking transport.</li> </ul>

2.2	Transmission of COVID-19 when arriving or departing school.	Staff, pupils, visitors, contractors, parents	Potential spread of infectious disease	<ul style="list-style-type: none"> <li>• When visitors arrive at school and are needing to attend the main building, they will first be instructed to follow hand hygiene procedures and asked to sign in through the Track and Trace system. They will also be instructed to wear a mask whilst in the building.</li> <li>• The school arrival procedures will be as follows: <ul style="list-style-type: none"> <li>○ Parents encouraged to use the lower gate for entrance/exit; however, both gates will be accessible.</li> <li>○ Face coverings are mandatory in indoor communal areas and for visitors.</li> <li>○ Parents are strongly advised to wear a face covering when collecting and dropping off pupils, including when outdoors due to the close confinement of the access to school.</li> <li>○ Packet Lane path will be one-way (<b>up</b> to school in the morning and <b>down</b> to the road in the evening).</li> <li>○ Parents will be encouraged to have only one parent collecting/dropping off to help reduce the overall number of adults on the grounds. Gates will be opened at 8:45am and locked at 9am allowing for a 15 minute window for parents to drop off pupils.</li> <li>○ Classrooms will be open from 8:45am.</li> <li>○ Parents will be encouraged to allow pupils to walk up to school independently, particularly pupils in Key Stage 2; a member of staff will be present at the lower gate and an additional member of staff will be present on the playground.</li> <li>○ School finish times will be 3:10pm for infants and 3:20pm for juniors to allow time for parents to leave the school grounds.</li> <li>○ Class teachers will escort their class onto the top playground and dismiss from their, allowing parents to wait on the middle and lower playground.</li> </ul> </li> </ul>

2.4	Transmission of COVID-19 through airborne particles due to face to face meetings with persons outside of the school staff.	Staff, visitors, contractors	Potential spread of the virus.	<ul style="list-style-type: none"> <li>• Good hand hygiene procedures will be carried out.</li> <li>• Visitors to the school will be informed of the school's control measures. <b>For regular visitors, they will be asked to take part in regular LFD testing.</b></li> <li>• Good ventilation will be in place.</li> <li>• Virtual meetings will be organised where possible, in order to limit the number of physical meetings.</li> </ul>

4.1	Failure to obtain consent/lack of participation	Staff, visitors, contractors	Transmission of the virus leading to ill health or potential death	<ul style="list-style-type: none"> <li>• School has issued the standard letter to all staff explaining the benefits of and arrangements for testing and seeking consent;</li> <li>• Testing is not mandatory for staff however participation in testing is strongly encouraged by the school in order to identify asymptomatic individuals, reduce the spread of the virus and protect colleagues and the wider community;</li> <li>• Staff are aware that they can stop participating in the testing arrangements at any point.</li> </ul>
4.2	Inappropriate sharing of information	Staff, visitors, contractors	Misuse of personal information and breaches of GDPR	<ul style="list-style-type: none"> <li>• All staff have been advised to read the school's privacy notice to enable them to understand what will happen to their data;</li> <li>• The test kit log and test results register are separate documents so that those signing for test kits cannot see the results of their colleagues;</li> <li>• Care is taken when handling personal information to ensure all necessary precautions are taken and that it is not shared with anyone who is not directly involved in dealing with the test results;</li> <li>• Care is taken when entering and saving personal information electronically.
